 - iii) Haddijatou Bayo: Should look into Texas Health and Safety Code vaping regulations.

II) Concrete Batch Plant Emissions

- a) The committee members coordinated plans to collect data related to emissions from concrete batch plants, including how far emissions may travel and what might be a healthy distance to certain areas.  - i) Dr. Afolabi: This would be helpful in informing optimal location of new neighborhood air monitors.
 - ii) Chair Thompson: Important to have both quantitative and qualitative data.
